- 1. Welcome and Introductions Stephen Hundley Minutes approved as circulated.
- 2. Brief Remarks from the Chancellor Nasser Paydar

The Chancellor expressed pride in IUPUI's tradition of assessment and reasserted the importance of data for making decisions.

Chancellor Paydar emphasized top priorities for the campus/es: 1. Student success (academic success, degree completion, participation in the community or further education after graduation); 2. Requested increased support from the Vice Chancellor for Research for faculty conducting research that serves students and the community; 3. Community engagement, for the benefit of both the community and the campus. He recommended that program reviews attend to these three areas.

3. Purpose of PRAC –Trudy Banta

PRAC has grown from 8 members in 1992 to its current enrollment of 65 members representing academic units, libraries, centers, and other campus offices. The committee's purposes are to provide faculty leadership for assessment, to provide guidelines for program reviews, guidelines for assessment of student learning, to provide small grants for assessment activities, and for sharing information about assessment.

Expectations of PRAC members include being present at meetings, communicating information to relevant people at the meeting, providing guidance and expertise for the represented unit, and reporting on good practices in assessment. Each unit must compile and submit an annual report so that we can demonstrate to the Higher Learning Commission that our continued commitment to assessment leads to ongoing improvements throughout the campus.

Reiteration of the importance of PRAC reports, their function, and the importance of timely submission – Stephen Hundley

4. Discussion of General Education/PULs/PGPLs/PCLs, including an overview, history, and work in progress – Trudy Banta and Stephen Hundley

Reviewed the context of IUPUI's three sets of principles and general education in the context of reaccreditation reviews over the past two decades. The assessment of PUL attainment that has been conducted for the past five years was sufficient for reaccreditation in 2012, but the uses of the data have not reached anticipated levels on campus.

The campus will be shifting to assessing general education using the AACU VALUE rubrics. This method recognizes that PULS aren't confined solely to courses designated as general education courses; they also are important in upper level courses where PULs are contextualized in disciplinary learning. This method of assessment is appropriate to an integrated general education system. It also has the advantages of recognizing high impact teaching practices, relying on authentic artifacts of student learning, and employing nationally validated tools.
